## Subject: Italy, a gateway to Europe 主題: 義大利, 通往歐洲的門戶

Italy is a member country of the European Union, a unique economic and political union between 27 European countries. The EU members have delegated the EU exclusive competence to legislate in certain areas, while national governments have maintained the competence to legislate in other sectors. What are the challenges for Taiwanese companies doing business in the EU?

Italy is the third largest economy in the European Union, it has a strong manufacturing capacity (2nd in the EU) particularly in luxury goods, automotive, and machinery and is an attractive destination for global investors. What are the opportunities and challenges for Taiwanese companies and investors?

In the EU, irregular migration has become central in public discussions and EU countries have individually pushed to crack down on migration. The current Italian Government has implemented many actions to try and reduce irregular migration but it is also being very active in promoting to attract foreign investments with a variety of national and regional incentives and attractive tax benefits for HNW individuals, new residents and pensioners.
